Scheme to look after elderly and vulnerable during Winter months worked well in previous years without need for formalisation. Church grounds voluntary strimming service working well, public thanks to all volunteers looking after their "patch". Strimmer to be serviced. Footpath linking church towards village hall in discussion with landowner. Whittington Dog Show discussed, not thought to be viable.
